



### The Future of the European Union

IEP emphasizes the establishment and development of a system of rules for European governance (structure, institutions and EU treaty reforms). Current reform debates, especially those regarding treaty reforms, as well as long-term trends of European integration are analysed and evaluated by interdisciplinary means and from many different perspectives.

### **Germany and Europe**

Since the establishment of the Federal Republic of Germany, the pursuit of European integration has been a constitutive element of the German raison d'État. Thus, German European policy and Germany's role within Europe are at the centre of IEP research projects, publications, and events.

### **Enlargement, Neighbourhood and Central Asia**

Since 1989, IEP has analysed the transformation of relations between Europe and the Central and Eastern European Countries by means of several research projects on stability, economic development, and their relevance with regard to the European integration process. The research questions focus on possibilities and limitations of the EU in shaping re-arrangement processes in the neighbourhood areas (in particular the East, including the Southern Caucasus and Central Asia) as well as its capacity to influence certain neighbouring countries through enlargement and neighbourhood policies.

### **European Foreign and Security Policy**

IEP has observed and analysed the development of European foreign policy from the proposal of a European Political Community all the way up to the current Common Foreign and Security Policy (CFSP), including the dimension of security and defence policy (CSDP). At the centre of the analyses lie both theory and practice of contractual basics, as well as actors and instruments involved.

### **Energy and Climate Policy**

Energy and climate policy has become one of the high priority topics in EU policy-making over the last couple of years. IEP observes current developments in this dynamic policy field, deals with processes of policy formation and analyses the potential outcomes of a common European approach.



### Forum

IEP is a forum, where current developments of European integration and key issues of European politics are discussed. The research results are presented to expert audiences from politics and academia, as well as to the general public through conferences and in publications. Events held on a regular basis are:
